ARTISTS AT WORK

For Artists and Artisans Interested in our Artists at Work Program

APPLICATION PROCESS

1. All applications will be screened. The Mountain View Arts Festival Committee reserves the right to refuse any application deemed to be inappropriate.
2. Each artist will be paid a \$100.00 honorarium. Artists who do not show up, regardless of cause, will not receive an honorarium.
3. Allocated display space is not transferable and may not be sublet, assigned, shared, donated, or traded.
4. Space will be provided for the artists to establish a working station where they will create their art and have an opportunity to meet prospective customers. A display of art for sale will be encouraged.
5. Artists/Artisans are responsible for supplying their own canopies, tables, chairs and any other equipment they require.
6. Artists must make available at least three (3) digital photographs depicting the item(s) or activity(ies) they will be demonstrating at the Festival with their application. If you do not have a website, email these photos to merrilee@mountainviewartssociety.ca.
7. Set-up and take down is the responsibility of the artist. Floors and walls need to be protected from mess (if applicable).
8. By submitting the application form you consent to the use of your name and application images in the Festival program as well as in other media to help promote the Festival.
9. By submitting the application form you hereby give the Mountain View Arts Festival Committee unrestricted right to use all photos taken on behalf of the Mountain View Arts Festival at the Festival itself in whatever manner deemed appropriate by the Mountain View Arts Festival Committee in the promotion of the Festival.
10. Deadline for applications is 4 pm, Thursday August 10, 2017.

INSURANCE & RESPONSIBILITIES

11. It is the responsibility of the artist/artisan to have and maintain adequate liability insurance coverage.
12. The Mountain View Arts Festival Committee, Town of Didsbury, associated businesses and individuals, staff and volunteers cannot be held responsible for injuries, damages or losses to participants or their goods.
13. The Mountain View Arts Festival Committee, Town of Didsbury, associated businesses and individuals, staff and volunteers cannot be held responsible for any lost or stolen items before, during or after the Festival.

FESTIVAL DATES, TIMES, AND SITE ACCESS

14. Artists/Artisans must remain in the Artists at Work area of Victoria Square Mall for the full term of the Festival – 11 am to 5 pm both Saturday and Sunday.
15. Access to the hall is possible on Friday, September 8, 2017 from 4 – 8 pm. Arrangements must be made with the Artists at Work Coordinator – all entrances to the hall are securely locked otherwise. See contact information below.
16. Set-up is from 9 am to 10:30 am daily.
17. Take-down is from 5 pm to 6:30 pm on Sunday.
18. Artists/Artisans may load and unload in front of the exhibit hall. We ask that you then move your vehicles to the side road immediately to the west of the mall in order to provide the best parking opportunities for our guests.

PRODUCT SALES & FOOD RESTRICTIONS

19. Applying artists must exhibit and/or sell only the items for which they were screened and accepted.
20. No artist can sell pop, water, other beverages, and/or food.
